To create an account, you will need to provide your first and last name, date of birth, a valid email address, and zip code. Upon completion of creating an Account, follow the online instructions to earn an entry into the Sweepstakes. The consumer must complete the registration form and upon

registration will receive one (1) entry in the Sweepstakes ("Entry"). The decisions of the Sponsor and Administrator are final in all matters relating to Sweepstakes.

You may use your SMS-enabled mobile phone to text "NERDS" to short-code 78896 to receive a link to the Website. Consent to texts is not a requirement or condition of entry.

For all Entries: All Entries must be received and recorded during the Promotional Period. No other forms of entry are valid. Subsequent Entries may be made by logging into your existing Account and following the online instructions. Limit one (1) Entry per person per day during the Promotional Period. By entering, entrant accepts and agrees to be bound by these Official Rules and the decisions of Sponsor, Administrator, and its judges, which are final in all respects.

Automated Entries are prohibited, and any use of automated devices will cause disqualification. Potential winner will be selected in a random drawing to be held on or about April 1, 2024, from among all eligible Entries received by Administrator, whose decisions are final in all matters relating to this Sweepstakes. Odds of winning depend on the number of eligible Entries received during the Promotional Period.

## 5. WINNER NOTIFICATION:

Potential winner will be notified by email call on or about April 1, 2024 and will be required to respond to the notification within forty-eight (48) hours indicating whether they can accept the prize. If a potential winner does not respond to the notification within the forty-eight (48) hour time period, prize will be forfeited, and an alternate potential winner will be randomly selected. Prize won by an entrant will be awarded to the authorized account holder of the e-mail address submitted with the entry regardless of the individual who submitted the winning Entry. Any alternate potential winner selected will also be required to respond to the notification within the time frame stated above.
