

**BLUE POINT BREWING POINT OF ILLUSION SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. 1. ELIGIBILITY:

The “Blue Point Brewing Point of Illusion Sweepstakes” (“Sweepstakes”) is open to legal residents of AL, CT, DE, FL, GA, MA, MD, ME, NC, NH, NJ, NY, PA, RI, SC, TN, VA and VT who are twenty-one (21) years of age or older at the time of entry.
