

**NÜTRL® TAKE U THERE TOUR SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS OPEN ONLY TO PERSONS WHO ARE, AT THE TIME OF ENTRY, LEGAL RESIDENTS OF AR, LA, NM, OR AND TX AND AT LEAST TWENTY-ONE (21) YEARS OF AGE OR OLDER. SWEEPSTAKES WILL BE GOVERNED BY UNITED STATES LAW. VOID WHERE PROHIBITED.

1. ELIGIBILITY:

The “NÜTRL Take U There Tour Sweepstakes” (“Sweepstakes”) is open to legal residents of AR, LA, NM, OK and TX who are twenty-one (21) years of age or older at the time of entry. Employees, contractors, directors, officers and agents of Anheuser-Busch, LLC, its affiliates and subsidiaries, advertising and promotion agencies, wholesale distributors, retail licensees, all other service and governmental agencies and their employees involved with the Sweepstakes, and members of their immediate families (spouse, parent, child or sibling; whether biological, adopted, step or in-law) or households (whether related or not) are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. 3. HOW TO ENTER:

(a) Internet: Visit <https://airbaton.net/w8fhbFRGC5Tzm7APqJdo> ("Website") during the Sweepstakes Period and follow the online instructions to complete and submit an online entry ("Entry" and "Internet Entry").

Automated Entries are prohibited, and any use of automated devices will cause disqualification. Entry Period 2 – Group 2: One (1) potential winner will be selected from among all eligible Entries received from Entrants who entered via the QR Code Entry and Internet Entry as outlined in Rule 2 and who selected "Thomas Rett Austin, TX 8/5/23 Tournament" from the drop-down menu during registration.

Entry Period 3 – Group 1: One (1) potential winner will be selected from among all eligible Entries received from Entrants who entered via the QR Code Entry and Internet Entry as outlined in Rule 2 and who selected "Snoop Dog & Wiz Khalifa Austin, TX 8/18/23" from the drop-down menu during registration.

Entry Period 3 – Group 2: One (1) potential winner will be selected from among all eligible Entries received from Entrants who entered via the QR Code Entry and Internet Entry as outlined in Rule 2 and who selected "Snoop Dog & Wiz Khalifa Houston, TX 8/19/23" from the drop-down menu during registration.

Entry Period 4 – Group 1: One (1) potential winner will be selected from among all eligible Entries received from Entrants who entered via the QR Code Entry and Internet Entry as outlined in Rule 2 and who selected “Drake Dallas, TX 9/15/23” from the drop-down menu during registration.

Entry Period 4 – Group 2: One (1) potential winner will be selected from among all eligible Entries received from Entrants who entered via the QR Code Entry and Internet Entry as outlined in Rule 2 and who selected “Drake Houston, TX 9/21/23” from the drop-down menu during registration.

Entry Period 5 – Group 1: One (1) potential winner will be selected from among all eligible Entries received from Entrants who entered via the QR Code Entry and Internet Entry as outlined in Rule 2 and who selected “Beyonce Dallas, TX 9/21/23” from the drop-down menu during registration.

Entry Period 5 – Group 2: One (1) potential winner will be selected from among all eligible Entries received from Entrants who entered via the QR Code Entry and Internet Entry as outlined in Rule 2 and who selected “Luke Bryan Fort Worth, TX 9/28/23” from the drop-down menu during registration.

5. WINNER NOTIFICATION:

All prizes will be awarded (time permitting). Potential winners will be notified by email or phone call and will be required to respond to the notification within forty-eight (48) hours indicating whether they can accept the prize. If a potential winner does not respond to the notification within the forty-eight (48) hour time period, prize will be forfeited, and an alternate potential winner will be randomly selected (time permitting). Concert date is subject change. Seating assignments to be determined by Sponsor, in Sponsor's sole discretion, and are subject to availability and change.
